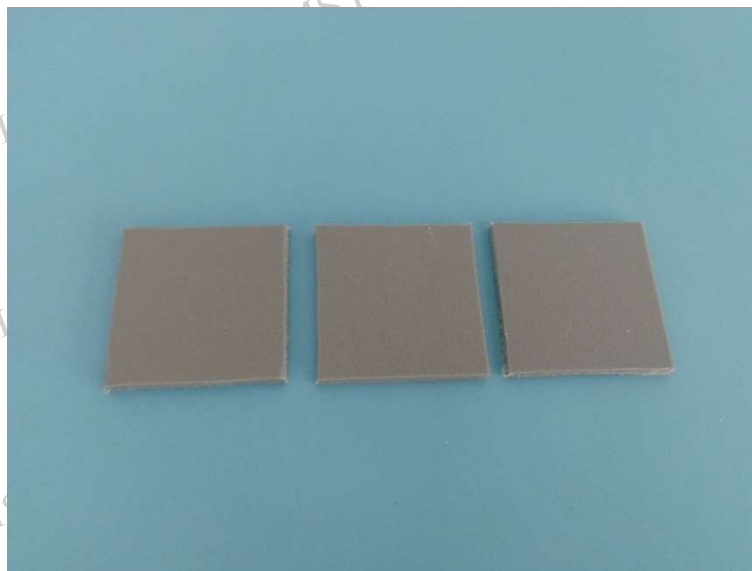


图 1-35%盐酸试验前照片

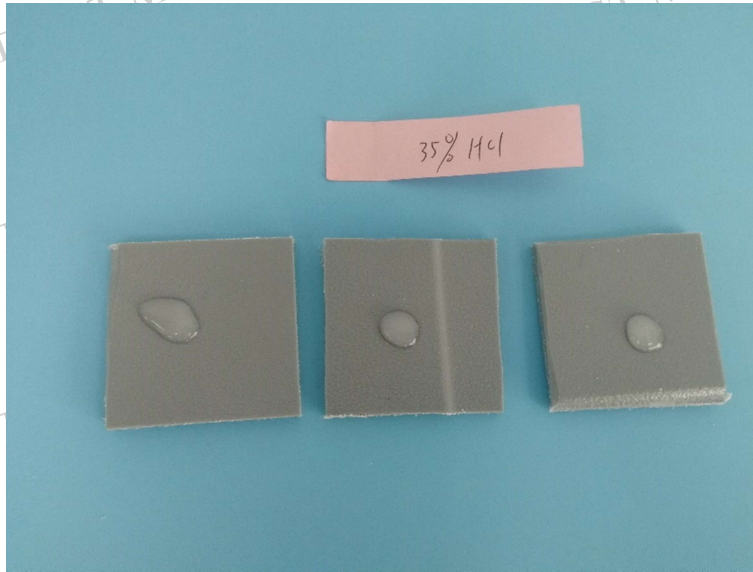


图 2-35%盐酸试验中照片
Photo 2-in 35% hydrochloric acid test

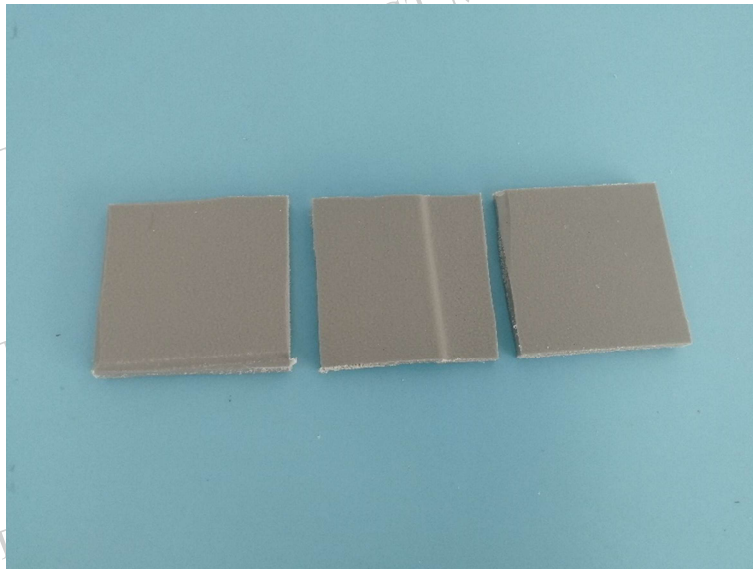


图 3-35%盐酸试验后照片

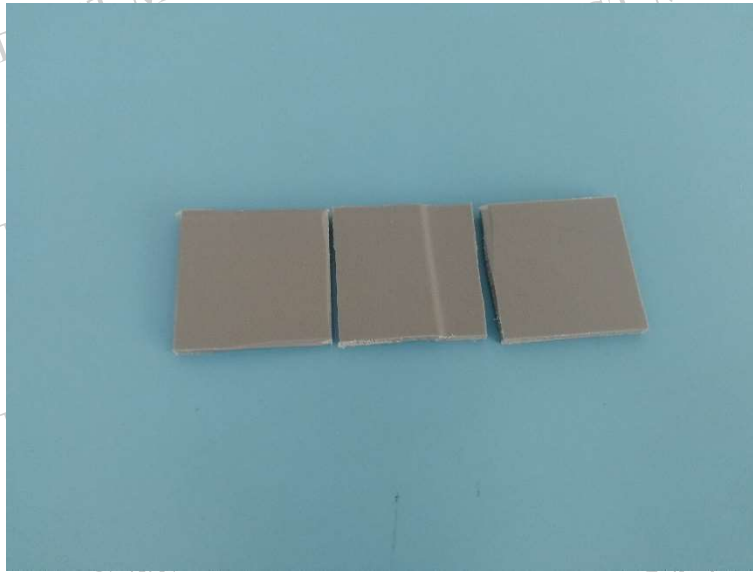


图 4-30%亚硫酸试验前照片
Photo 4-before 30% sulfite test

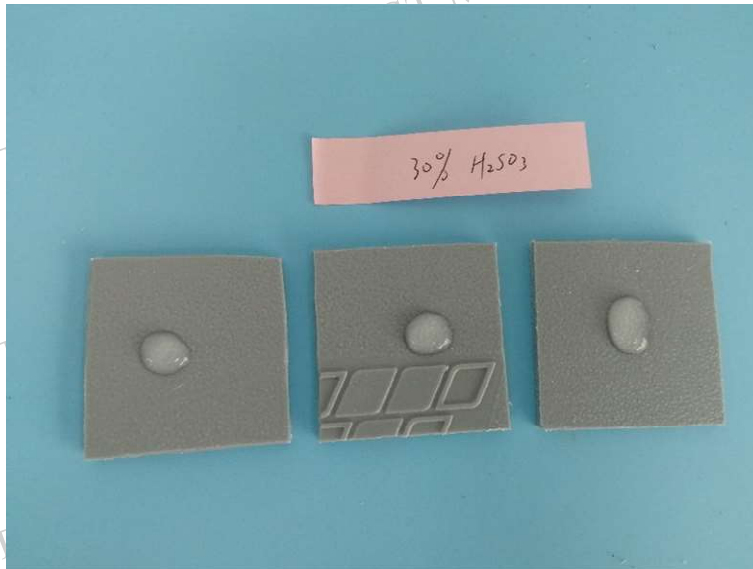


图 5-30%亚硫酸试验中照片

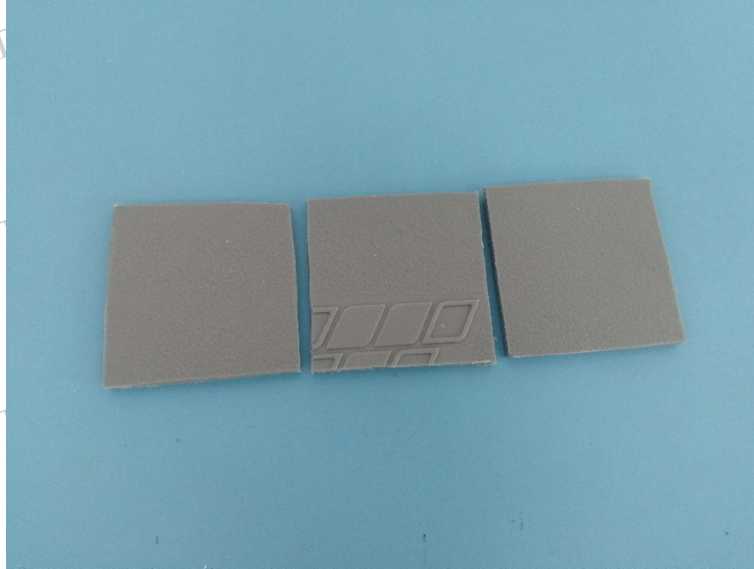


图 6-30%亚硫酸试验后照片
Photo 6-after 30% sulfite test

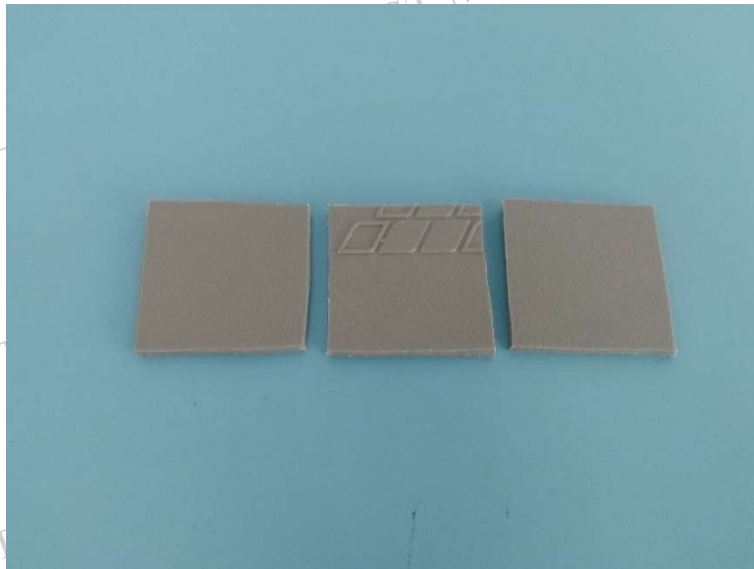


图 7-30%硝酸试验前照片

Photo 8-in 30% nitric acid test

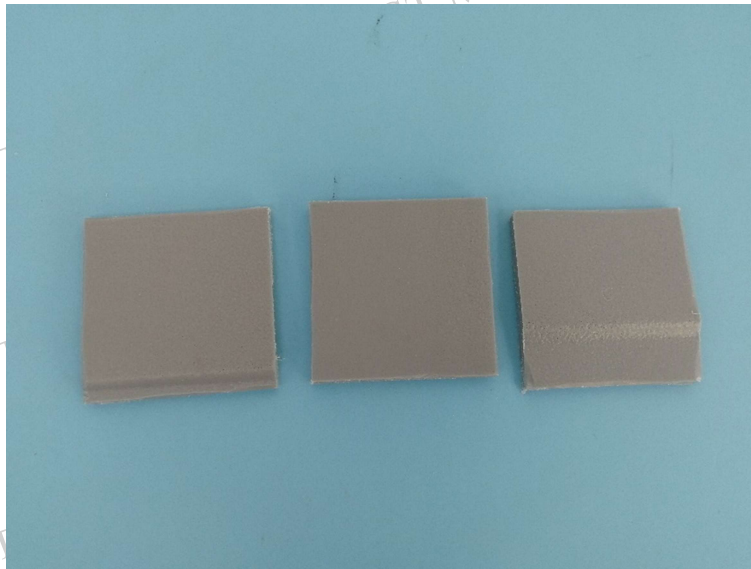


图 9-30%硝酸试验后照片

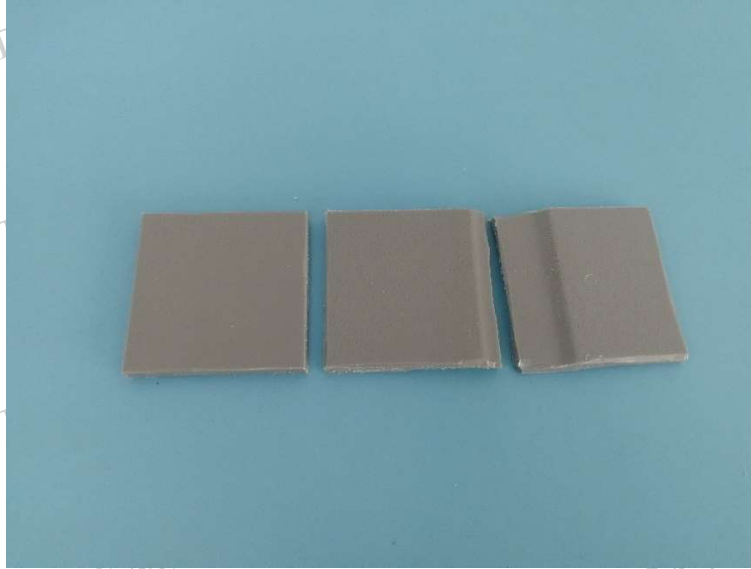


图 10-50%磷酸试验前照片

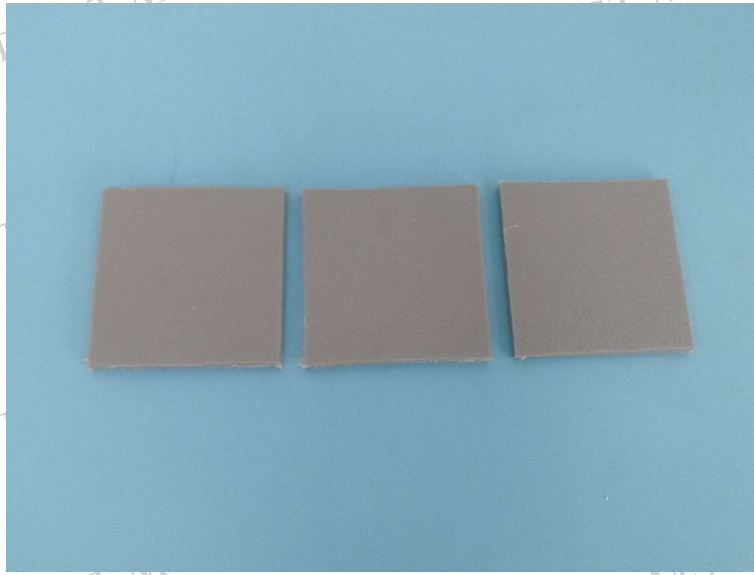


图 12-50%磷酸试验后照片
